There are rare situations during treatment that unforeseen treatment may need to be added to your care. If that should occur, we will inform you and provide any options you may have. The fees for services performed are due in full at the time they are performed. If you have insurance benefits available, your estimated percentage and deductible are due at the time of service. Once the insurance has paid or failed to pay, the full balance is expected from you at the next billing cycle.
